268/19 Clerks Report

The Clerk reported that the workshop rebuilding project has started today. A lot of time has been spent in the last couple of weeks making certain that everything was organised. Thanks were proposed to the Clerk for the extra work required so that the project started on time. This was proposed by Cllr Mrs J Bunney and seconded by Cllr C Bigg and agreed unanimously.

269/19 Accounts for Payment

270/19 Bank Reconciliations – August and September 2019 The Clerk reported that the reconciliations for August and September 2019 have been completed and that Cllr Mrs B Wood will be informed.

271/19 Co-options

The Council had received two applications for co-option. Both applicants were present and made short presentations to the meeting and were asked questions by members.

The first applicant was discussed and a vote was taken. There were 7 votes for and 2 abstentions for Mr N Anderson. Mr N Anderson was duly co-opted onto Tiptree Parish Council.

The second applicant was discussed and a vote was taken. There were 9 votes for Mrs A Lawrence. Mrs A Lawrence was duly co-opted onto Tiptree Parish Council.

272/19 Royal British Legion Poppy Appeal

A request had been received from the Royal British legion for the free use of the meeting room in the Community Centre on two days for the Poppy Appeal administration. Following discussion, it was proposed by Cllr C Bigg and seconded by Cllr Mrs J Bunney that the request would be granted on the following conditions:

- That it is the Council's policy not to allow free hire to any group.
 Therefore, a grant to the total amount of the hire will be given. An invoice will be sent to you for the hire of the room and a grant for the same amount will be issued to cover it.
- That the room is subject to availability
- That the room must be vacated by the time given or costs will be incurred

This was agreed unanimously.

273/19 Grants

A grant application from Kyds was considered. After discussion, it was proposed by Cllr R Mannion and seconded by Cllr Mrs D Webb that £1000.00 should be given to the group. A vote was taken and there were 6 votes for and 3 against. The proposal was carried.

Cllr Mrs J Bunney asked that a formal grants policy should be drawn up and the Clerk said that this would be placed on the agenda for the Policy & Finance meeting on 4th November 2019.

274/19 Grove Lake

A request had been received from the NSPCC Book Fair Committee to place a sign on the railings at Grove Lake. It was proposed by Cllr Mrs J Bunney and seconded by Cllr C Bigg that this should be allowed. This was agreed unanimously.

275/19 Advertising and Obstruction

Cllr R Smithson told the meeting that the Highways committee had been due to discuss this matter at its recent meeting but that the meeting was cancelled due to being inquorate.

Following discussion, it was suggested that Cllr R Smithson should approach the Zone Manger at Colchester Borough Council and see if there is anything that the Zone Wardens can do. Cllr C Bigg also said that he could speak to the Mynott Court management.

276/19 Land at Barbrook Lane – Appeal against Planning Permission
It was noted that the Parish Council has been informed that the Secretary of
State has decided to Recover the Appeal. The Inspector will be asked to
provide a report and then a timetable will be notified to the Council, by when
the decision will be issued.
