07/25 **Public questions:**

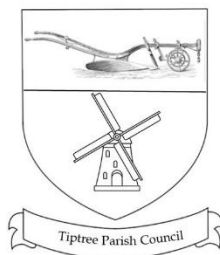
The member of the public raised concerns to the committee over the state and ownership of the track for item 11.
