The committee received a report about:

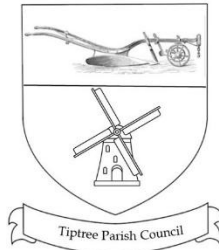
- The reason Millins planters' plants are surviving this weather so well.

51/26 Consideration of hire of GRPF Bernardos application:

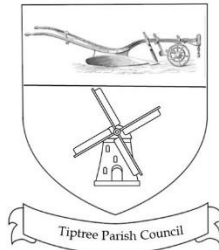
After discussion It was proposed, seconded and unanimously **resolved** that the committee approved this hire of Grove Road Playing Field.
